Good stewardship is an act of faith as we make choices and an act of love when we move forward with faith. We are the stewards of the gifts God provides our school. Pre-registering offers us a great look at the upcoming school year and helps us in planning for supplies, staffing, and other related items. We hope to see every child back at St. Mary next year. The following information provides our fee structure to assist your decision-making as you consider what is best for your child's education.

Returning Student Registration Fee: (books, technology, activities)

\$185.00 per child – 50% due on registration day, **August 2, 2020**; 50% due **November 13, 2020**.

New Student Registration Fee: (books, technology, activities)

\$195.00 per child – 50% due on registration day, **August 2, 2020**; 50% due **November 13, 2020**.

Tuition Assistance: Our Tuition Assistance dollars are made available to those in need through the gracious contributions of our parishioners and donors. **All returning family applications must be submitted online by March 31, 2020. THESE FUNDS ARE LIMITED and we urge you to apply online if there is a need.** Please note there is a \$35 non-refundable fee for every application. We are using a third party, an outside agency, FACTS, to process your application due to KHSAA standards and to add a layer of financial privacy for families. This company takes the guesswork out of financial aid assessment, helping our school award aid to only those most in need. Smart Tuition: Allows families to set up monthly, quarterly, or semi-annual payments. If making payments, this option is required.

5% Discount: Pay tuition in full by registration day, August 2, 2020, to receive this discount.

Pre-School Tuition Rate- \$1,475 Tuition may be paid in monthly installments of \$147.50. Payment plan will start in August and end in May. (\$250 discount if you have other children in SMWS.)

THESE FUNDS ARE LIMITED and we urge you to apply online if there is a need.** Please note there is a \$35 non-refundable fee for every application. FACTS Grant & Aid Assessment will be conducting the financial need analysis for St. Mary of the Woods School for the upcoming 2020-2021 school year. This company takes the guesswork out of financial aid assessment, helping our school award aid to only those most in need. Families applying for financial aid will need to complete an application and submit the necessary supporting documentation to FACTS Grant & Aid Assessment. Applicants can apply online at <https://online.factsmgt.com/signin/3WLR1>.

Once an online application has been completed, the following information will need to be sent to FACTS to complete the application process:

- Copies of your most recent Federal tax forms including all supporting tax schedules.
- Copies of your 2019 W-2 forms for both you and your spouse.
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF.
